2023 TRIENNIAL ELECTION CHALLENGE

In October 2024, I received notification that the 2023 Triennial Election for the Unit I Shop Chairperson had been challenged. The U.S. Department of Labor was here during the months of October, November, December and January performing interviews and gathering information for their investigation. UAW Local 2209 has entered into a voluntary compliance agreement to conduct new nominations, election, and installation for the office of Unit I Chairperson of UAW 2209. This election will be conducted under the supervision of the U.S. Department of Labor. A copy of the correspondence is attached.
