UAW Legal Services — Tips

Did you know that if your will names someone to inherit a bank account, retirement account, life insurance policy or deed, and your beneficiary designation for one or more of those assets is different from what you have in your will, the beneficiary designation controls. For example, if your will names your current spouse to receive your life insurance proceeds, and your ex-spouse is still on the life insurance policy as the beneficiary, your ex-spouse will inherit that asset. Make sure your beneficiary designations match the designations you have in your will.

When naming individuals to inherit assets by beneficiary form (such as life insurance proceeds, bank accounts, 401(k) accounts), make sure those beneficiaries you have named know where to find the necessary documents after you die so that they can claim the funds you have left them. Too often, heirs are in the dark about what the decedent left them and do not know where to find necessary documents, leaving valuable assets unclaimed.

You should apply for retirement benefits about three months before the date you want your benfits to start. If you are not ready to retire, but are thinking about applying soon, you should visit Social Security's website. If you already have enough Social Security credits to quality for benetits, you can use the online Retirement Estimator at www.socialsecurity.gove/estimator. This is a convenient, secure and quick financial planning tool that allows you to create your own plan, if you don't already have one.
