## NationsBenefits OTC Alert

There was a data security incident resulting in access to some UAW Trust members. NationsBenefits mailed out notice to those impacted with steps individuals can take to protect their information.

Free credit monitoring and identity theft assistance and insurance is offered by NationsBenefits. If you have questions call 1-866--313-7993 or the number included in your letter. If you are impacted, a free 24-month membership to Experian's Identity Works is being offered. The letter will have an activation code necessary to enroll and must be completed no later than August 31, 2023. A credit card is not needed.

You are also entitled under federal law to a free copy of your credit report every 12 months. Obtain your free copy by going to www.AnnualCreditReport. com or call 877-322-8228.

House Speaker Kevin McCarthy also wants to create a commission to look into making cuts to Social Security and Medicare.

It was mandatory during our work life that taxes would be deducted for Social Security and Medicare. We did not have an option to opt out. And there should not be any cuts to our benefits.

#### Social Security Payments



In general, most recipients receive their payments based on the day born.

1st thru 10th 2nd Wednesday 11th thru 20th 3rd Wednesday 21st thru 31st 4th Wednesday

If you are receiving Supplemental Security Income (SSI) it will be on the 1st of the month.

If you are receiving both SSI and Social Security the SSI will be on the 1st of the month and Social Security by the 3rd.

SSI payments are only in February, March, May, June, August, September, November, and December. Payments are doubled for four of the months.

If you started receiving benefits prior to May 1, 1997, you will receive payment by the 3rd of every month.

If you are receiving benefits on behalf of another individual it will be based on their date of birth.

If you become a citizen or resident of another country there may be sanctions that prevent payment of benefits.

Advance Designation allows capable adult and emancipated minor applicants and beneficiaries of Social Security, Supplemental Security Income, and Special Veterans Benefits to choose one or more individuals who could potentially serve as their representative payee in the future, if the need arises. If you think you may need to do this contact Social Security.

### Medicare Enrollment



Less than 80% of our 2,700 plus retirees are of Medicare age. 65 years or older. About 50 retirees will be turning 65

within the next three months. This does not include retiree spouses.

Expect a first letter about 90 days before your 65th birthday. It will include information how to enroll, and how enrollment impacts Trust health plan elections.

A second letter goes out to members not enrolled in Medicare during the month of their 65th birthday. It will explain the Trust Medicare policy and made aware of the higher costs if not enrolled.

A third letter will go out to members that are not enrolled in Medicare the month following their 65th birthday.

To avoid higher costs it is important to follow the instructions in the first letter and enroll in Medicare.
