The locally elected leaders fight this fight too. We need our members' support in fighting these companies. Keeping records and letting your locally elected leaders know is important, and so is supporting the process. Companies violate the contract for several reasons. Maybe they just don't know better, maybe they don't care, maybe they feel it's their only move forward, I believe that many times they want to divide the membership. They know we must follow the grievance procedure, or even if we file charges, the process can take a long time. This is frustrating and I understand that it may appear that nothing is happening. The truth is, we are fighting back, the wheels of progress just take more time than we would like. Standing together in SOLIDARITY is what scares the company more than anything. We are our sisters' and brothers' keepers so please support your union.

Region 2B may have some new brothers and sisters around the Dayton area soon. Members of CareFlight Air & Mobile Services at Miami Valley Hospital will be voting to join the UAW June 11th and 12th! The petition was filed with the NLRB on May 13th and we are eagerly awaiting to expand our union family. This is about helping those workers fight for pay equity, benefits, and safety for them and their patients. Workers across America are realizing that if they want to be treated with dignity in the workplace, they need to organize, and that's exactly what these proud CareFlight workers are doing.

Contracts, organizing, and education are your director's top priorities. The Region 2B staff has been putting together some excellent programs to help educate the members and leaders for the more than 300 units we serve. This is very exciting for me because I know that every elected person, every appointee, and every single member needs to be armed with the knowledge to fight for our rights. This is why I am encouraging all locals to send people from their leadership to the UAW Region 2B Leadership Conference, July 14 -19, 2024. None of us can do it alone, but together we can make a difference. There is a lot of work to do, and it is a very busy year.
